Further Rules and Regulations:

1. No refunds
2. All vendors must pay rent prior to setting up for the event. Spot will not be officially reserved until payment is received.
3. No loaning or subletting of space(s)
4. Collection of monies, collection of taxes and other governmental requirements are the responsibility of the individual vendors.
5. Vendors are responsible for clean-up in their selling areas. All garbage and trash is to be put in the dumpster located in the front parking lot of the property.
6. Any merchandise or display equipment left on the grounds at the end of the day on the event will be disposed of by the management without liability.
7. No open flames
- 8. You must provide your own covering/tent for your space.**
9. No guns or ammo should be bought, sold, traded or given away.
10. No swords or knives shall be sold to an individual under the age of 18 unless a parent or guardian is present.
11. Food vendors must get proper licenses to sell their product in Kendall county.

12. Items that are banned for sale, but not limited to: farm animals, fireworks, drug paraphernalia, and obscene material, counterfeit logos and labels on apparel. Additionally, no copyright and not trademark infringement items will be sold in this market. No selling of contact lenses or any type. Violators will be removed from the market immediately with no refund.
13. Sellers will not construct anything on the premises without the express permission of management.
14. Each vendor will conduct themselves in a business-like manner if a seller, dealer or vendor causes trouble to other vendors, customers, or management then the management reserves the right to refuse to rent to that vendor and if necessary evict that vendor immediately with no refund.
15. There will be a \$30 charge on all returned checks; all future payments will have to be made in cash or money order.
